RELEASE OF LIABILITY FOR MINOR PARTICIPANTS & COACHES

READ BEFORE SIGNING

IN CONSIDERATION OF my child/ward or me named here _____
being allowed participate in any way in the Hershey Cup, the undersigned acknowledges,
appreciates, and agrees that:

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) to me and my child from the activities involved in these programs are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation and my attendance at the Hershey Cup; and,

2. I willingly agree to comply with the Hershey Cup rules, regulations, guidelines and safety protocols and the terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or symptoms of COVID-19, I will remove my child from the participation, not attend future tournament related events and bring such to attention of the Tournament Director immediately; and,

3. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Hershey Soccer Club; its directors, officers, officials, agents, employees, volunteers, referees, referee coordinator, Eastern Pennsylvania Youth Soccer Association, other participants, sponsoring agencies, sponsors, advertisers, and Derry Township, Derry Township School District, and any owners and lessors of premises used to conduct the Hershey Cup, games, and events ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property incident to my child or my involvement or participation in the tournament, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.

5. I, the parent/guardian, assert that I have explained to my child/ward: the risks of participation in the tournament including playing tournament games, his/her responsibilities for adhering to the rules, regulations and including the safety guidelines and protocols, and that my child/ward understands this agreement.

I, FOR MYSELF, MY SPOUSE, AND CHILD/WARD, HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
